

Summary of Changes to BAA 12-04 through Amendment 0002

A. Amendment 0001 makes the following changes to Department of Homeland Security Broad Agency Announcement (BAA) 12-04:

1. On the cover page of the BAA, the due date for the white papers is hereby revised from January 13, 2012 to January 27, 2012.
2. On the cover page of the BAA, the due date for the submission of proposals is hereby revised from March 13, 2012 to March 30, 2012.
3. In Section 1.7, entitled Response Dates, the due date for the submission of white papers is revised to January 27, 2012.
4. In Section 1.7, entitled Response Dates, the due date for the submission of full proposals is revised to March 30, 2012.
5. In Section 3, entitled Eligibility, the following information is hereby added:

Foreign entities or organizations are eligible to apply for this Broad Agency Announcement. However, it is strongly recommended that these organizations have a U.S. partner.

6. In Section 4.3, entitled White Paper Preparation and Submission Guidelines, the first sentence of the paragraph is hereby deleted in its entirety and is replaced with the following:

The due date for white papers is no later than 4:30 P.M. (Local Eastern Time) on **27 January 2012**.

7. In Section 4.3, entitled White Paper Preparation and Submission Guidelines, the second to the last sentence in the first paragraph is hereby replaced with the following:

Initial DHS S&T evaluation of the white papers will be issued via e-mail notification on or about **24 February 2012**.

Summary of Changes to BAA 12-04 through Amendment 0002

8. In Section 4.4, entitled Full Proposal Preparation and Submission Guidelines, the paragraph is replaced in its entirety with the following:

The due date for receipt of full proposals is 4:30 P.M. (Local Eastern Time) on **30 March 2012**. **Full Proposals WILL NOT BE ACCEPTED after the published due date.** It is anticipated that award announcements will be made on or before **04 May 2012**. As soon as the final proposal evaluation process is complete, the offeror will be notified via e-mail of its selection or non-selection for an award. Proposals exceeding the page limit will not be evaluated.

9. In Section 4.6, entitled Significant Dates and Times, the third paragraph is hereby deleted and is replaced in its entirety with the following:
