

## Amendment 00001 to Broad Agency Announcement 12-10

---

A. The purpose of Amendment 00001 to Broad Agency Announcement (BAA) 12-10 is to perform the following changes: (1) notate a change in the title of the Federal Business Opportunities announcement for BAA 12-10; (2) change the DHS logo on the cover page of the document, (3) revise the Table of Contents of the BAA to incorporate the new Appendix D, (4) revise Appendix A to add additional reference language for TACCOM 2 Requirements Documentation, (5) Add Appendix D to the BAA, (6) make minor formatting changes to the BAA, and (7) provide Set 1 of Frequently Asked Questions to the vendors.
