

## Amendment 00004 to Broad Agency Announcement 13-008

---

A. The purpose of Amendment 00003 to Broad Agency Announcement (BAA) 13-008 is to perform the following changes: (1) revise language on the cover page of the BAA; (2) revise the due date for Full Proposals on the cover of the BAA; (3) revise the date of notification of evaluation of white papers in Section 4.3 of the BAA; (4) revise the due date for the receipt of Full Proposals in Section 4.4 of the BAA entitled "Format and Content of Full Proposals"; (5) revise the due date for the commencement of negotiations in Section 4.4 of the BAA entitled "Format and Content of Full Proposals"; and (6) update a column heading and the due dates for several events in the table titled Anticipated Schedule of Events in Section 4.6 of the BAA entitled "Significant Dates and Times". Accordingly, the BAA is amended as follows:

1. On the cover page of the BAA, the day of the week for the due date for the submission of Full Proposals is hereby deleted in its entirety and is replaced with the following:

2. On the cover page and throughout the BAA, the following language is hereby added:

On page 14 of the BAA, under Section 4.3 entitled Format and Content of White Paper (DHS Biological Threat Characterization Program Project Proposal Form), the date for the notification of the DHS S&T Evaluation of the Biological Threat Characterization Program Project Proposals Forms (White Papers) is hereby revised to **28 May, 2013**
5. On Page 15 of the BAA, under Section 4.4 entitled "Format and Content of Full Proposals", the first sentence of the paragraph subtitled "Full Proposals" is hereby deleted in its entirety and is replaced with the following:  
**The due date for receipt of Full Proposals is 4:30 P.M. (Local Eastern Time) on June 24, 2013.**
6. On Page 15 of the BAA, under Section 4.4 entitled "Format and Content of Full Proposals", the third sentence of the paragraph subtitled "Full Proposals" is hereby deleted in its entirety and is replaced with the following:

It is anticipated that negotiations for award will commence on or about **July 11, 2013**.
